

## NOW THIS INDENTURE WITNESSETH AS UNDER:-

- 1. The name of the trust shall be "Hind Guru Educational & Social Welfare Trust "
- 2. The registered office of the trust shall be at "84-D, GROUND FLOOR, TIKONA PARK, OKHLA, NEW DELHI-110025" or at such place all over india and abroad as the trustees may decide from time to time,
- In order to effectuate the said trust the settlors has hereby handed over a sum of Rs.1100/= (Rupees One Thousand One Hundred only) to hold the same together with all other properties that may be acquired out of the same or otherwise any hereafter be subject to the said Trust for the objects and purpose hereafter expressed with powers and terms condition herein contained concerning the same.
- 4. The Settlors shall be the chairman (Noor Nawaz Khan S/o Ahsan Ali Khan R/o 84-D, GROUND FLOOR, TIKONA PARK, OKHLA, NEW DELHI-110025 of this trust and they are also nominated the following persons as other trustees of the aforesaid trust:-
- a. MOHD. NAWAZ KHAN S/O AHSAN ALI KHAN R/O 84-D, GROUND FLOOR, TIKONA PARK, OKHLA, NEW DELHI-110025.
- b. SHAHZAD ALI KHAN S/O SHAHZAD ALI KHAN R/O H. N. 127/5,

  OKHLA, NEW DELHI-110025

- 5. The Aims and Objectives of the Trust shall be as follows:
- a To work for the upliftment of educationally and economically minority community in particular and other in general.
- 6: The object for which the trust is established are Education,
  Relief to poor, Medical relief or advancement of any other
  object of general public utility and for such purpose as,
  but not involving the carrying of of any other activity for
  profit:
  - a. To spread and promote learning or training of all non professional, professional and technical education like computer, management studies, media and journalism, book publishing, newspaper publishing, teacher training, vocational courses., industrial training in all its branches is such a manner as the trustee may think fit including:
  - To work for the community development & welfare for the economically & socially backwards without any discretion and welfare work for saheed & their dependents.
  - ii To provide opportunity for education to economically poor and deserving persons.
  - iii To start educational library, play room and to arrange competitions in every field of education for growth of



society by giving them prizes/ certificates etc.

To arrange & management the vocational training institutions in typing, computer education fine art & craft music, dance, painting, yoga & physical education, Faison deigning, cutting and tailoring, embroidering & beautician, paramedical& alternative Sciences and other profes sional training courses/ subjects etc.

To encourage sports & cultural programs, work of bravery, pollution control, de-alcoholic activities hostel for working men & woman and students and establishment of Orphanages, old age home, children and widow home, anath aashram.

vi To register the medical practioner in the integrated medical system of treatment by constituting a expert council and to laid down courses of study and to frame rules- regulation to conduct examination in the field of medical technology & computer education and academic subjects and award certificate and degree & diplomas.

vii To accept donation grants, gifts, & other offering and
financial & non financial Assistance from government &
non government agencies & individual etc.

viii rub the institute for primary medical aid training in all India and to held exam and provide proficiency certificates to trained person and provide affiliation for well fare organization to conduct the primary medical aid course.

ix To taken up lawful steps for education of social evils such ad dowry child marriage, etc.

- Imparting education and training to economically backward and deserving students without any distinction of caste, colour or creed.
- xi Establishment and maintenance of branches, schools, colleges, study centres and other institutions for imparting Physical fitness Education, Self Defence and education and training for students all over india and Internationally.
- xii Establishment and support of fellowship, scholarship and prizes for enhancement of education and training.
- xiii Teaching and training and other concerning Arts in all over
  India
  - xiv Various types of teaching and training arts for publicity and expersion
  - To take a bold and proper step to promote the education to awake/aware the public towards the education and its proper teaching.
  - xvi To establish institutions/educational Services/clubs/social welfare Activities.
  - xvii To take urgent step to remove the difficulties, if rises during the processor to promote education
  - xviiiOrganize educational and vocational training programme with special concern for deprived sections, women/girls and unemployed youth to provide new skills, refine/sharpen/ upgrade the existing skills leading to employment, self employment and income generation.
  - xix To open training camps and workshops for the development of arts, plays and culture and raise funds through subscriptions,

donations, trade to fulfills the aims and objects

- xxi To develop and establish such out of school activity centers for the children of underprivileged class of society where they could have the benefit and joy of participating in sports, games, artistic like painting, clay and wood work, music, dancing and develop skills in debating, elocutions, participate in excursions, educational trips and such other activities.
- xxii To provide scholarships, rewards, certificates and other incentives to deserving students
- extinition open institution for fine arts, computer, electronics, home management for women and special courses such as cutting ,tailoring etc. with the approval of concerned government authorities.
- xxiv) To set up institution, schools, colleges, trusts or societies in connection with the objects of the society

- xxv) To work for the promotion of education & to establish educational institutions in backward areas
- xxvi)To provide chances of higher and technical education for the schedule tribes schedule castes and OBC & Rural background in India & abroad.
- Nursery & high Schools, higher education & also the schools for cultural development of the masses especially in the field of dance, (all types of classical including kathakali etc., music both Indian and Western etc.)
- xxviii) To impart education of foreign languages, literature, culture and education to Indian students; and to impart

the education of Indian Regional languages including Hindi, urdu, knowledge of Indian culture, fine arts, sculptures, computer, music, painting, dance etc on the basic of this education, to provide certificate, diploma, advance diploma, graduate and post graduate degrees to it's students

- xxix)To create nutritional awareness in community for healthy motherhood and control of malnutrition.
- xxx) The trust may provide consultation services to other organisation (Govt. or Non Govt.) in the areas of health education and environment with or without charges.
- xxxi)To purchase/acquire land from the concerned government authorities and to construct school/college/masjid buildings thereon for the cause of the trust.
- xxxi) To actively join hands with the government of India and other countries to promote human rights education and help legal social and economic discrimi nation of women and their exploitation in different ways.
- b) Relief to the poor which includes:-
- i) Establishing or rendering help to any institution for the alleviation of human suffering.
- ii) Subscription, contributions and/or donations to any public charitable trust or fund or institutions for promotions of any public charitable objects.
- c) Medical relief in such manner as the trustee may think fit, swincluding:

- i.) Endowment to and help or support to hospitals, Health centres and dispensaries.
- iii) The creation, maintenance, supply or of support of garden, gymnasiums, physical culture centres, Hospital, Nursing Home, Sport centres and other means or recreation for advancement of sports, Health and Hygiene.
- iv) Grant of Medical help to the poor and grant of medical help to deserving persons during epidemic, famine, flood, earth quake or any unforeseem calamity or war like operations.
- d) Other objects of general public utility, includes:
- i) To construct, to built-up, to-develop, to maintain, to run, to manage, to take over the community hall, masjid for poor people, sarai, cultural centres, rest house or any accommodation for the welfare of the people.
- ii) To buy the land from government authorities or any other private organisation or any person.
- iii) To establish and develop institution for the physically handicapped and disabled or mentally retard person any to provide them education, food, clothing or other help.
  - iv) To help to the widows, the needy, the orphans, the olddestitute and the in capacitated / handicapped in the form of monetary assistance, medical aid, scholarship for education.
  - 6. For the furtherance of the object of the trust the investment or use of Trust fund for the time being in force, the

trustees will have the following powers:

- i) To accept any donations, contribution, grant, gift or subscription in cash or in kind form any person, body of persons, trust, govt. towards the corpus of trust fund to meets the objects mentioned herein before.
- ii) To apply the whole of part of the income of the trust funds or accumulation thereof or whole or part of the corpus of the trust funds, on any one or more of the objects of the trust, as the trustee may in their direction from time to time determine.
- iii) To invest or deposit trust funds and incomes of the trust in the forms and modes as prescribed under section 11(5) of the income tax act and rules made there under:-
- iv) To purchase, sell, mortgage, dispose of or otherwise deal with any property for trust. To let out demise any immovable property comprised in the trust fund for such period and at such rent, on such terms and conditions as the trustee in their discretion may think fit.
- v) To enhance Rural Development Programme in field of Agriculture and to implement planning regarding rural development programmes. To enhance and development programmes regarding women empowerment.
- vi) To open account with any bank, or banks to operate such account and to give instructions to the bank and to provide for opening and operation of such account by the trustee or by any agent appointed by the trustees.
- vii) To adjust, settle, compromise, compound, refer to arbitration all actions, suits claims, demandsand proceedings regarding

the trust fund. Arbitrator shall be appointed by trustes.

- viii) To appoint constituted attorney or agent or to delegate to such attorneys or agents or any of the power vested in the trustee under these presents and from time remove such agents and to appoint others in his or their place.
- ix) To make, alter or modify schemes, rules and regulations for carrying out the objects of the trust and the management of the affairs thereof and running any institutions in furtherance of the objects of the trust.
- (including all or any of the trustee as committee or administrator on managing trustee(s) or otherwise) for the purpose of the trust in such manner and subjects to such rules and regulations as the trustees may prescribe and also to appoint or provide for the appointment of separate trustees to hold any property or any fund or investments subject to the provisions of this deed in such manner and subject to such rules and regulations as the trustee may from time to time fit.
- xi) To start, abolish, discontinue and charity or charitable institutions for the benefit of general public and to impose any condition to any subscription or donation made by them.
- xii) To set apart the whole or part of these incomes or the corpus of trust fund of part of the object of the trust.
- xiii) To take over acquire manage control or aid any existing institution or institutions having objects either wholly or


in part a similar to the object of this trust an on such terms and conditions as may be through expedient.

- xiv) To transfer all or any part of the property asset, liabilities and engagements of this trust to any one or more of the charitable trust, societies, institutions or associations.
- 8) It shall be lawful for the trustee to give aid by way of donation out of the income of corpus of the trust fund or otherwise to different charitable institutions, societies organisation or trust to enable such institutions, societies, organisation or trust to start maintain or carry out such charitable objects.
- 9) The trustee shall have the power, that instead of acting personally to employ and pay any agent to transact or tobo any act whatsoever in relation to the trust of these presents including the receipt and payment of money with out being liable for loss and shall be entitled to be allowed and paid all charges and expenses incurred there by.
- 10) It shall be lawful for the trustee to borrow moneys either on the security of any property comrised in the trust fund or otherwise/for all or any of the purposes of these presents and it shall be lawful for the trustees to make such borrowings on payment of such interest and otherwise on such terms and conditions as they may decide from time to time.
- 11) The receipt of a persons authorized by the trustees or a resolution of the board of trustees, for any money paid or

any property transferred or delivered to the trustees in execution of any of the power thereof or for purchase moneys or any property authorized to be sold shall effectually discharge any persons so paying or transferring or delivering.

- 12) The trustee will be entitled to receive any remuneration as trustee but may reimburse themselves of all expenses actually incurred by them in connection with the trust on their duties relation thereto.
- 13) The number of the trustee shall not be less be two and more than fifteen at any time. If the number of the trustees shall fall below there, the trustees shall not except for the purposes of filling any vacancy, as so long as the numberies below the said minimum.
- 14) The trustees for the time being will be at liability to appoint additional trustee(s) within the number mentioned above for such period or on such terms as to retirement and reappoint as the trustees for the time being consider proper.
- 15) The trustees, will be at liberty to resign on giving one month's notice of his intention to do so.
- 16) The trustees once appointed, shall hold his office until he resign or is declared insolvent or convicted by a court for criminal office involving moral turpitude or otherwise become untill or incapable to acting at any time. Any trustees on account of any gross misconduct on the part of any trustees in his public life or pertaining to the affairs .
- 17) The general administration / affairs and the presents of this deed shall be conducted by the chairman.



- 18) The trustees may from time to time frame by-laws rules and regulations for the conduct of the affairs of the trust its office bearers and employees.
- 19) The amendments of the trust deed shall be made by two third majority. The trustee may from time to time frame rules for the conduct and regulation of the meetings of the trustee.
- i) That one third of the trustees shall form a quorum for meeting of the trustees.
- ii) All the matters will be decided by majority. In the vent of any tie, the settler (in his absence trustee presiding over the meeting) shall have a casting vote.
- iii) Resolutions passed without any meeting of the trustees but by circulation thereof and evidenced in writing under hands of two third of the trustees shall be as valid and effectual as a resolution duly passed at a meeting of the trustees.
- 20) The trust hereby created shall be irrevocable.
- 21) That we, the settler trustees, shall be entitled to nominate a success or to myself. The successor so nominated by me shall be chairman or vice chairman of the trust after my death or incapacity to act as chairman, and will act along with other trustees. Myself, my successor, will be entitled to nominee another person in the place of the one decreasing or resigning, but if he does not so nominate, the surviving trustees will continue to function and administrator the trust.
- 22) The managing committee shall consist of all the trustees and shall elect office bearers of the managing committee from

If the trustees at any time decide that it is expends to discontinue the trust any money or property belonging to the trust after payment of all expenses and liabilities property incurred shall be distributed among such other charitable organisation, having similar objects as of the trust, as the trustee may decide.
- 25. The trustee shall maintain true accounts of all funds received and money expended by the trust and of all matters in respect of which such receipts and expenditure take place and of the assets, credits and liabilities of the trust and the accounting year shall be from 1st April to 31st March.
- 26. Once at least in every year the accounts of the trust shall be audited and the correctness of the profit and loss accounts.


